Principal's Report

P&C Annual General Meeting – 6/3/17

The past twelve months has seen a lot accomplishes within our school. We have managed to concrete the primary staff car park, resurface the multi-purpose court (in spite of the weather), upgrade our oval watering system and improve storage in the school. Though not funded until this year, we have also managed to upgrade the curtains in the hall and have the floor surface resealed. All of this work has added to improved facilities.

In addition, we are in the process of upgrading our signage around the school to include the directional signs at the Molong and Orange Street entrances, names of buildings and rooms, as well

as a welcome sign. We are hoping that the new signage, in line with our Asset Management building numbers will assist staff when calling in any building issues or IT faults. It will take us some time to finalise installation of all signage.

Each year we have worked hard to improve attendance, behaviour support and learning in our school. Our attendance has been reported to have increased a little more for 2016 – this is usually for Semester 1. It has gone from 93.2% to 93.4%. We experienced significantly fewer high level behaviours and associated consequences as PBL has been more consistently embedded across the school. With fewer in-class issues, engagement in learning has continued to improve with teachers involved in on-going professional learning. We continue to raise the bar of expectation in all that we do. NAPLAN results showed that the average growth in reading was twenty points about the average for all students in NSW, ten points above in spelling and eight points above in the area of grammar and punctuation. Numeracy is an area for further development. Although, our Aboriginal students scored an average of eleven points higher compared to Aboriginal students across our state.

We received positive feedback in relation to our end of year presentation ceremony and were pleased to see students receiving their awards. The Banner Award ceremony was also well attended. As such, we will continue to run our presentation ceremony through the day this year.

We are about to enter a significant time of change in our school with the system used for administration being updated. This change will have a huge impact on the operation of our office until such time as staff are familiar with the system. It will mean that things may go much slower than they have in the past. We ask for the patience of the whole community. With this change, we will also be POP
